



## International Credit Mobility (ICM), KA107-2017

## Cooperation between Polish and Partner Country Higher Education Institutions (HEIs) Information on grant awards

Within the 2017 Call for proposals 127 Polish HEIs submitted applications for ICM (17 more than in 2016). All applications met formal eligibility criteria and were assessed against quality criteria.

Within a single application cooperation with each Partner Country was assessed individually (separately). Thus 793 assessments were conducted (192 more than in 2016). The average number of Partner Countries per application was 6 (the exact value is 6.2 against 5.5 last year). 36 applications envisaged cooperation with a single Partner Country. The highest number of Partner Countries in a single application was 32.

As the result of the qualitative assessment:

- 103 proposals met a minimum quality threshold for all Partner Countries envisaged in the application. However, due to the fact that in case of some countries the minimum score allowing to award the grant was higher than 60, only 88 proposals were granted the funds for all Partner Countries envisaged in the application;
- 23 proposals met a minimum quality threshold for some of the Partner Countries envisaged in the application;
- 16 HEIs did not met minimum quality threshold for any of the Partner Country envisaged in the application.

111 Polish HEIs (20 more that in 2016) were awarded a grant for at least one mobility.

Demand for funds to be allocated for mobilities with Partner Countries was substantially higher than funds available in 2017 for Poland. For details please refer to the table below (data presented per "budgetary envelope"):

Taking into account the budget availability and high expectations of Polish HEIs to cooperate with Partner Countries, a decision was taken to provide opportunities for cooperation to as many beneficiaries as possible and not only the ones with the highest scores.

Staff mobility was given priority due to its importance for further development of didactic cooperation and for good implementation of student mobility. Taking into account objectives of KA107 projects the preference was given to incoming flows from Partner Countries to Poland.

The table below presents the minimum score qualifying for at least one mobility with a given region:

In order to provide the mobility opportunities to as many HEIs as possible, the National Agency decided:

- to reduce the number of flows taking into account:
  - (1) quality assessment results,
  - (2) requested number of flows;
  - (3) budget available in a given region (budgetary envelope);
- to base the allocation on the following principles: for students a maximum duration of 5 months (150 days), for staff a maximum duration of 7 days (5 days of stay + 2 travel days), unless in a given region the demand met the budget available (then the limitations have not been applied). Due to substantial oversubscription for funds, in case of some HEIs applying for cooperation with several countries from the same region or sub region (valid for regions 6 and 8), funds were awarded for mobilities with one or several but not all countries in the given region/sub region. The NA urges HEIs to revise their mobility plans and adjust it to the activities described in the Annex 2 to the grant agreement (issued individually for each HEI). Flexibility given in the financial agreement provides opportunities to make some changes to the original mobility plan described in the Annex 2. An absolute embargo relates to a change from one Partner Country to another, even within the same region.

When the number of awarded mobilities is not sufficient to run cooperation with all partners envisaged in the project proposal, the NA urges Polish HEIs to analyse the situation as provided in the Annex 2 and define HEIs with which cooperation is going to be realised. All Partner Country HEIs should be immediately and duly informed about situation arising from the notification of the 2017 selection results.

In project proposals cooperation with 82 Partner Countries belonging to all geographical regions was requested. No Partner Country was omitted in granted projects.

There were 16 772 mobilities requested in all submitted applications including:

- 9 847 staff mobility flows (incoming to Poland: 5 190, outgoing to Partner Countries: 4 657);
- 6 925 student mobility flows (incoming to Poland: 4 825, outgoing to Partner Countries: 2 100).

Applications accepted for funding envisage 3 895 mobilities (2 444 incoming to Poland and 1 451 outgoing to Partner Countries), including:

- 2 881 staff flows (incoming to Poland: 1 694, outgoing to Partner Countries 1 187);
- 1 014 student flows (incoming to Poland: 750, outgoing to Partner Countries 264).
